Planning Commission 5 year Term/5 members

Planning Commission- Charter §68- 5 members; and Code Chapter 31 “ each to serve for five (5) years or until his successor takes office, except that the terms of members first appointed are staggered such that the first appointed member serves for one (1) year, the second appointed member serves for two (2) years and the third appointed member serves for five (5) years.”

This commission is responsible for the Town’s long-range comprehensive plan, and is the sponsor of the Town’s zoning code. It views changes to and interprets the zoning code, and reviews and approves development plans as required by charter. Makes recommendations to Mayor and Council regarding planning and development issues.

Historic District Commission 3 year term/5 members

Historic District- Code §200-14(C)- at least 5 member- “ Commission members shall be appointed for terms of three years, except that the terms of the initial appointments shall be staggered so that three members shall serve terms of three years and two members shall serve terms of two years, so that not more than three appointments shall expire in a given year. Commission members may be reappointed.”

This commission shall review any application to construct, alter, reconstruct, move, or demolish a landmark, site, or structure within the Historic District. The Commission also has the authority to: 1) advise applicants as to available tax incentives; 2) prescribe rules and regulations regarding the transaction of its business; 3) adopt rehabilitation and new construction design guidelines and criteria; 4) acquire historic preservation and other easements; 5) recommend modifications of boundaries for landmarks, sites, and structures; and 6) designate the Maryland Historical Trust to recommend preservation of sites, structures, or districts of historical significance within the Town of Snow Hill.

Charter §69- 5 members; and Code 200-29 “ The initial appointees to the Board, one shall be designated to serve until the first day of January following the date of the enactment of this chapter, two until the first day of the second January thereafter and two until the first day of the third January thereafter or until their successor takes office. Their successors in office shall be appointed on the expiration of their respective terms to serve three years.”

This board shall hear applications for special exceptions, variances, and other appeals under the Town Zoning Code.

This board shall hear appeals of housing code enforcement, regulation, and interpretation of the code’s provisions.
